Introduction

Bobby Orozco Jr. serves as the Regional Vice President for the American Federation of Government Employees (AFGE), Council 100 (C100), AFL-CIO for Region 6, which covers the states and U.S. territories of Arizona, California, Guam, Hawaii, Nevada, and Saipan.

Basis of this Letter

On Thursday, June 24, 2021, I noticed that at approximately 10:17 AM, Pacific/Arizona Daylight Time, I received a voice message from AFGE Local 1250 Executive Vice President Greg Ford, from phone number 602-320-3203, which lasted about one (1) minute and four (4) seconds. The dictation of that message has been transcribed as follows:

Bobby, hey, it's Greg Ford, it's about 10:15 Arizona time . . . umm . . . I text messaged Juan and I, I quit. And . . . which I also texted . . . I'm assuming that's what he want . . . Umm . . . and I subsequently after that text message, I had a family emergency at home, so I left, I actually left the airport three hours early . . . Umm and Juan said I'll take your text message . . . umm . . . as a, as a formal that you quit. I said Juan you can do whatever you want at this moment, I don't care. Anyway, so I just wanted to let you know that . . . umm . . . I quit. I'm done. Umm . . . I'm done . . . I'm done, I just done, I'm done. I don't have the energy, I don't have the time, I don't have the patience to deal with Juan and, and, and his bullshit . . . Anyway . . . umm, that's it! Want to send me an email, want to have a meeting, I uh, I, just, let me know, okay? Thanks. Bye.

Acceptance of Resignation

As Regional Vice President for AFGE Council 100 for Region 6, which covers Arizona and Nevada, encompassing Local 1250, I hereby acknowledge receiving and accepting, on behalf of

Council 100 and Region 6, Mr. Ford's resignation and his personal decision to vacate the position of Executive Vice President unsolicited and without coercion. I have suggested to LP Casarez and his E-Board to hold an emergency E-Board meeting and accept the resignation, of Mr. Ford, which was sent to LP Casarez via text; and then subsequently in voice message form to myself, as Council 100 Region 6 Vice President; and to subsequently appoint an individual to serve out the remaining term.

Conclusion

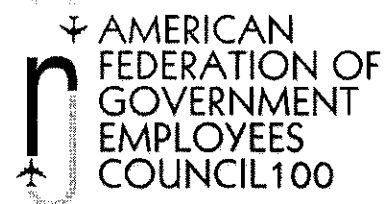
