



## **AFGE TSA Local 1250 Meeting Minutes**

### **I. Call to order**

Secretary Jovan Petkovic read the meeting minutes from the last member meeting, held on June 18, 2024. Minutes were presented to the body. Approval of minutes from last meeting was performed. Nevada Vice President Becky Cooper submitted correction to the minutes.

- **Reading of Financial Reports**
  - The treasurer presented detailed financial reports for the months of April, May, and June, covering revenue, expenses, and the current bank balance.
- **Solicitation for Motion to establish Arbitration Committee**
  - A motion was made to establish an arbitration committee to review case requests for arbitration, assess their suitability, and make recommendations. The committee will consist of 4 members plus 1 executive board member, with a quorum of 3 required to vote on cases.
  - Present members Jacob Edmonds, John Palmer, Jill Dejanovich, and Marcos Crespo volunteered to be on the Arbitration Committee.
- **Political News**
  - The political coordinator provided updates on the local's political activities, including the assignment of a new LPO, continued work on the Title 5 bill and TSO commuting burden bill, and endorsements of political candidates.
- **AFGE Wins**
  - A detailed summary was provided of the significant wins and achievements of the AFGE union, including reversing anti-worker policies, securing pay raises and benefits for federal employees, and expanding union representation.
- **New Business**
  - No new business was presented.
  - Secretary Jovan Petkovic entered motion to adjourn the meeting, Member Eric Hatcher second the motion. Motion passed. Meeting adjourned.
